 a. the date of preparation and all subsequent revisions b. boundary lines, dimensions to the nearest hundredth of a foot, lot numbers, and lot areas
 the name, location, and width of all existing and proposed rights-of-way, easements, common areas, or any other dedications within and adjacent to the subject property the applicable parcel numbers of all properties
One (1) 8.5x11 reduced copy of the plat of annexation.
Additional documentation, plans, or surveys as requested by the Department of Community Development.
