**ORDINANCE NO. 7763**

**AN ORDINANCE AMENDING ORDINANCE NO. 7647,  
ADOPTED APRIL 4, 2019, ENTITLED,  
“AN ORDINANCE AMENDING TITLE XI, CHAPTER 110, SECTION 110.11;  
TITLE XI, CHAPTER 112; AND TITLE XI, CHAPTER 115  
OF THE LOMBARD VILLAGE CODE IN REGARD TO VIDEO GAMING  
AND LIQUOR LICENSES FOR ESTABLISHMENTS WITH VIDEO GAMING”**

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Section 14 of Ordinance No. 7647, adopted April 4, 2019, is hereby amended by revising the reference therein to “June 30, 2020” to read “December 31, 2020.”

**SECTION 2:** That Section 15 of Ordinance No. 7647, adopted April 4, 2019, is hereby amended as follows:

- A. The references therein to “June 30, 2020” are hereby revised to read “December 31, 2020”; and
- B. The references therein to “July 1, 2020 to December 31, 2020” are hereby revised to read “January 1, 2021 through June 30, 2021”.

**SECTION 3:** That Section 16 of Ordinance No. 7647, adopted April 4, 2019, is hereby amended by revising the reference therein to “June 30, 2020” to read “December 31, 2020”.

**SECTION 4:** That all other provisions of Ordinance No. 7647, adopted April 4, 2019, not amended hereby, shall remain in full force and effect.

**SECTION 5:** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
